			<p>come into contact with others and are supervised at all times.</p> <ul style="list-style-type: none"><li>• For Students the relevant member of staff calls for emergency assistance immediately if Students' symptoms worsen.</li><li>• The parents of unwell Students are informed as soon as possible of the situation by a relevant member of staff.</li><li>• Where contact with a Student's parents cannot be made, appropriate procedures are followed in accordance with those outlined in governmental guidance.</li><li>• Unwell Students who are waiting to go home are kept in an area where they can be at least two metres away from others.</li><li>• Areas used by unwell staff and Students who need to go home are appropriately cleaned once vacated, using a disinfectant and care to be taken when cleaning all hard surfaces.</li><li>• If unwell Students and staff are waiting to go home, they are instructed to use different toilets to the rest of the school to minimise the spread of infection.</li><li>• Any Students who display signs of infection are taken home immediately, or as soon as practicable, by their parents – the parents are advised to contact NHS 111 immediately or call 999 if the Student becomes seriously ill or their life is at risk.</li><li>• Any members of staff who display signs of infection are sent home immediately and are advised to contact NHS 111 immediately or call 999 if they become seriously ill or their life is at risk.</li></ul>

			<p><b>From 16<sup>th</sup> August 2021</b></p> <ul style="list-style-type: none"><li>• From 16 August 2021, children <b>under the age of 18 years and 6 months will no longer be required</b> to self-isolate if they are contacted by NHS Test and Trace as a close contact of a positive COVID-19 case (unless they have been identified as a close contact of a suspected or confirmed case of the Omicron variant, irrespective of vaccination status and age).</li><li>• Instead, children will be contacted by NHS Test and Trace, informed they have been in close contact with a positive case and advised to take a PCR test.</li><li>• We would encourage all individuals to take a PCR test if advised to do so.</li></ul> <p><b>Over 18 years of age</b></p> <ul style="list-style-type: none"><li>• 18-year-olds will be treated in the same way as children until 6 months <b>after their 18th birthday</b>, to allow them the opportunity to get fully vaccinated. At which point, they will be subject to the same rules as adults and so if they choose not to get vaccinated, they will need to self-isolate if identified as a close contact.</li><li>• Continue to have a role in working with health protection teams in the case of a local outbreak. Admitting people into school	Students Staff	Infection control	<ul style="list-style-type: none"> <li>Students, staff and other adults <b>should not</b> come into school if they have symptoms, have had a positive test result or have been instructed to quarantine.</li> <li>Anyone, including staff or students, within the school who appear to have COVID-19 symptoms are sent home, advised to avoid using public transport and, wherever possible, be collected by a member of their family or household and to follow advice.</li> <li>In the case of a student awaiting collection, they should be taken to a room away from other Students and supervised.</li> <li>If the member of staff is in close contact with the child, then they should wear appropriate PPE.</li> <li>A window should be opened for fresh air ventilation if possible.</li> <li>Any rooms that have been used for this purpose should be cleaned after they have left.</li> <li>As with anyone within the household, staff, students/siblings should follow the PHE guidance for households with possible or confirmed COVID-19 infection.</li> </ul>	MED		✓
