Cleaning of	Staff	Infection	<ul> <li>need for increased ventilation while maintaining a comfortable temperature should be balanced.</li> <li>On dedicated transport:</li> <li>It is recommended that children and young people aged 11 and over continue to wear a face covering when travelling to secondary school or college.</li> <li>It is no longer recommended maximising distance and minimising mixing, but unnecessary risks such overcrowding should be minimised.</li> <li>Children, young people and adults should follow United Kingdom Health Security Agency (UKHSA) advice on when to self-isolate and what to do.</li> <li>They should not board dedicated transport or public transport if they have symptoms or other reasons requiring them to stay at home due to the risk of them passing on COVID-19.</li> <li>If a child or young person develops COVID-19 symptoms, however mild, while at school, they will be sent home.</li> <li>They should avoid using public transport and, wherever possible, be collected by a member of their family or household.</li> <li>In exceptional circumstances, if parents or carers cannot arrange to have their child collected, and it is age-appropriate and safe to do so, the child should walk, cycle or scoot home. Self Isolation of positive cases	Students	Spread of infection	<ul> <li>Monday 17th January 2022: If a staff member or pupil tests positive they may be able to end their self-isolation period before the end of the 10 full days. They can take a lateral flow device (LFD) test from 6 days after the day symptoms started and another LFD test on the following day. The second LFD test should be taken at least 24 hours later. If both these test results are negative, and the staff member or pupil does not have a high temperature, they may end their self-isolation after the second negative test result and return to their education setting.</li> <li>An LFD test should not be taken before the sixth day of the isolation period, self-isolation should only end after 2 consecutive negative LFD tests which should be taken at least 24 hours apart.</li> </ul>	MED	✓
Living in same household with a student/sibling with a positive case	Siblings Students Others	Spread of infection	<ul> <li>From 16 August 2021, you will not be required to self-isolate if you live in the same household as someone with COVID-19 (unless they have been identified as a close contact of a suspected or confirmed case of the Omicron variant, irrespective of vaccination status and age) and any of the following apply: <ul> <li>you are fully vaccinated</li> <li>you are below the age of 18 years 6 months</li> <li>you have taken part in or are currently part of an approved COVID-19 vaccine trial</li> <li>you are not able to get vaccinated for medical reasons As long as the student/sibling is not displaying any COVID-19 symptoms, then the above guidance applies.</li> </ul> </li> <li>Pupils aged 5 years and over and live in the same household as someone with COVID-19, and are not legally required to self-isolate, are strongly advised to:</li> </ul>		

			•	Take an LFD test every day for 7 days, or until 10 days after the household member who has COVID-19 started their self-isolation period if this is earlier Take this daily LFD test before you leave your home for the first time that day If an LFD test is positive, you should immediately self- isolate to prevent you from passing the infection on to other people. If you have completed your required isolation period after testing positive for COVID 19 and returning back to school you are advised not to take another PCR test within 90 days of this result <b>unless you develop any new main</b> <b>symptoms of COVID-19, or if you are required to take</b> <b>a PCR test upon entry into the UK</b> . If you have a positive PCR test result within 90 days of a previous positive test result you must stay at home, self- isolate and follow the steps in this guidance again.

If a parent or carer insists on a Student attending your school, you can take the decision to refuse the Student if, in your reasonable judgement, it is necessary to protect other Students and staff from possible infection with COVID-19.</li> <li>Your decision would need to be carefully considered in light of all the circumstances and current United Kingdom Health Security Agency (UKHSA) advice.</li> </ul>	MED	*

Admitting people into school	Students Staff	Infection control	<ul> <li>Students, staff and other adults should not come into school if they have symptoms, have had a positive test result or have been instructed to quarantine.</li> <li>Anyone, including staff or students, within the school who appear to have COVID-19 symptoms are sent home, advised to avoid using public transport and, wherever possible, be collected by a member of their family or household and to follow advice.</li> <li>In the case of a student awaiting collection, they should be taken to a room away from other Students and supervised.</li> <li>If the member of staff is in close contact with the child, then they should be opened for fresh air ventilation if possible.</li> <li>Any rooms that have been used for this purpose should be cleaned after they have left.</li> <li>As with anyone within the household, staff, students/siblings should follow the PHE guidance for households with possible or confirmed COVID-19 infection.</li> </ul>	MED	✓
